# **Applications**

Trigonox 301 is an efficient peroxide formulation for the production of controlled rheology polypropylene (CR-PP) in an extrusion process. An important advantage of Trigonox 301 is that the final CR-PP contains a low content of volatiles originating from peroxide decomposition products. Trigonox 301 forms no acetone and no tert-butanol.

#### Half-life data

The reactivity of an organic peroxide is usually given by its half-life (t1/2) at various temperatures. For Trigonox 301 in chlorobenzene half-life at other temperatures can be calculated by using the equations and constants mentioned below:

## Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

Method	The Heat Accumulation Storage Test is a recognized test method for the
	determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New
	York and Geneva).

## Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (Ts max.) for each organic peroxide product.

Ts Max.	40°C (104°F)
Ts Min.	10°C (50°F)
Note	When stored under these recommended storage conditions, Trigonox 301 will remain within the Nouryon specifications for a period of at least six months after delivery.

## Packaging and transport

The standard packaging is a 30-liter Nourytainer for 25 kg peroxide formulation. Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Trigonox 301 is classified as Organic peroxide type D; liquid, Division 5.2; UN 3105.

# Safety and handling

Keep away from open fire, sparks and other sources of heat or ignition. Avoid contact with reducing agents (e.g. amines), acids, alkalis and heavy metal compounds (e.g. accelerators, driers and metal soaps). PLEASE Store Trigonox 301 ABOVE 10°C!
